### ACCEPTABLE USE POLICY

**THIS ACCEPTABLE USE POLICY CONSTITUTES A LEGAL AGREEMENT BETWEEN YOU AND EXPERT WEBSITE SERVICES LLC. ("EXPERT WEBSITE SERVICES LLC", "WE" OR "US") a provider of retail web hosting, e-mail, electronic commerce, and domain name services ("Services").**

#### A. ACCEPTANCE:

1. YOU AGREE TO REFRAIN FROM THE FOLLOWING EXAMPLES OF PROHIBITED CONDUCT;

#### B. PROHIBITED CONDUCT

You will violate this Policy if you engage in the following examples of prohibited activities while using our Services:

##### Spamming

##### Facilitating a Violation of this Policy

##### Infringing Intellectual Property Rights

- (i) Engaging in any activity that: infringes or misappropriates the intellectual property rights of others, including copyrights, trademarks, service marks, trade secrets, software piracy, and patents held by individuals, corporations, or other entities; violates privacy, publicity, or other personal rights of others

##### Obscene Speech or Materials

- (i) Using EXPERT WEBSITE SERVICES LLC Services to advertise, transmit, store, post, display, or otherwise make available child pornography. EXPERT WEBSITE SERVICES LLC shall notify law agencies when it becomes aware of the presence of child pornography on or being transmitted through EXPERT WEBSITE SERVICES LLC Services

- (iii) Promoting products or services that involve a significant risk of death or injury to any persons, or damage to business or other entities or property

##### Defamatory or Abusive Language

- (i) Using EXPERT WEBSITE SERVICES LLC'S Services as a means to transmit or post defamatory, harassing, abusive, or threatening language

## Targeted Online Marketing Solutions

### Forging of Headers

- (i) Forging or misrepresenting message headers, in whole or in part, to mask the originator of the message

### Illegal or Unauthorized Access to Other Computers or Networks

- (i) Accessing illegally or without authorization computers, accounts, or networks belonging to another party, or attempting to penetrate security measures of another individual's system (often known as "hacking")
- (ii) Engaging in any activity that might be used as a precursor to an attempted system penetration (i.e. port scan, stealth scan, or other information gathering activity)

### Distribution of Internet Viruses, Worms, Trojan Horses, or Other Destructive Activities

- (i) Distributing information regarding the creation of and sending Internet viruses, worms, Trojan horses, pinging, flooding, mail bombing, or denial of service attacks
- (ii) Engaging in activities that disrupt the use of or interfere with the ability of others to effectively use the network or any connected network, system, service, or equipment

### Export Control Violations

- (i) Exporting encryption software over the Internet or otherwise, to points outside Canada or the United States

### Illegal Activities

- (i) Engaging in activities that are determined to be illegal, including advertising, transmitting, or otherwise making available ponzi schemes, pyramid schemes, phishing scams, fraudulently charging credit cards, and pirating software

### Gambling

- (i) Engaging in or promoting gambling

### Promoting Illegal Substances

- (i) Illegally displaying or promoting any type(s) of illegal substance

### Instructing others in Prohibited Activities

- (i) Providing instructions with respect to any activities listed in (a) through (n) above

### Other Activities

- (i) Engaging in any other activity, whether lawful or unlawful, that EXPERT WEBSITE SERVICES LLC in its sole discretion determines to be harmful to customers, operations, reputation, goodwill, or customer relations.
