Allied Marketing Agreement

Terms of Alliance

It is understood that the aforementioned allied marketing partner will receive a 10% commission for referring business to Expert Website Services LLC that results in an executed contract as long as the following criteria are met:

- 1) Expert Website Services LLC is notified (by partner) of a potential referral BEFORE a proposal is sent to the customer. This means that if we find out during the project lifecycle that business is a result of a referral from the strategic partner, we may or may not be able to pay the commission. In this event, commissions are at the sole discretion of Expert Website Services LLC.
- 2) The referral results in an executed contract AND the payment terms of the contract are met by the customer. Agreements that are sent to outside collection agencies or result in litigation are no longer commissionable.

Commissions will be paid within 15 days from the completion of a project and receipt of final payment from the customer.

Term and Termination

This agreement will automatically renew in one year from the effective date unless either party cancels the agreement, in writing. This agreement may be terminated (i) without cause at any time, by either party with thirty day's written notice to the other party; (ii) by written mutual agreement of the parties; or (iii) by either party in the event of a material breach by the other party of the terms and conditions set forth in this agreement.

Force Majure

Neither party shall be deemed in violation of this agreement if it is prevented from performing any of its obligations hereunder due to strikes, failure of public transportation, civil or military authority, act of public enemy, accidents, fires, explosions or acts of God, including, without limitation, earthquakes, floods, winds, or storms. In such an event, the intervening cause must not be the fault of the party asserting such an excuse, and the excused party is obligated to promptly perform in accordance with the terms of the Agreement after the intervening cause ceases.

Entire Agreement

This agreement and attached proposal contains the entire agreement of the parties and there are no other promises or conditions in any other agreement whether oral or written. This agreement supersedes any prior written or oral agreements between the parties. This agreement may be modified or amended only if the amendment is made in writing and signed by both parties.

Applicable Law

This agreement shall be governed by the laws of the State of Nevada.

Indemnification and Liability Waiver

The partner agrees to hold harmless Expert Website Services LLC, and any of its representatives, owners, employees, partners, or stakeholders from liability resulting from web development projects.
