Therefore, the parties agree as follows:

Provision of Services

Beginning on the effective date, KT Graphics LLC will provide the services described in recital A and B, pending receipt of any content needing to be supplied by the customer.

Payment

Customer will pay KT Graphics LLC the amount agreed to in recital A and B; and according to terms therein. In the event that customer does not make payment to KT Graphics LLC in a timely manner, KT Graphics LLC can impose a 1.5% per month interest fee. Additionally, late payment may result in cancellation of service including web hosting account termination. Customer will be liable for any attorney fees or collection costs associated with not making timely payments.

Term

This agreement will expire in one year from the effective date unless the attached proposal notes otherwise. Web hosting accounts and website maintenance agreements auto-renew until terminated by either party.

Termination

This agreement may be terminated (i) without cause at any time, by either party with thirty day's written notice to the other party; (ii) by written mutual agreement of the parties; or (iii) by either party in the event of a material breach by the other party of the terms and conditions set forth in this agreement. It is understood that the customer must pay for any and all work completed before terminating the agreement.

Force Majure

Neither party shall be deemed in violation of this agreement if it is prevented from performing any of its obligations hereunder due to strikes, failure of public transportation, civil or military authority, act of public enemy, accidents, fires, explosions or acts of God, including, without limitation, earthquakes, floods, winds, or storms. In such an event, the intervening cause must not be the fault of the party asserting such an excuse, and the excused party is obligated to promptly perform in accordance with the terms of the Agreement after the intervening cause ceases.

Entire Agreement

This agreement and attached proposal contains the entire agreement of the parties and there are no other promises or conditions in any other agreement whether oral or written. This agreement supersedes any prior written or oral agreements between the parties. This agreement may be modified or amended only if the amendment is made in writing and signed by both parties.

Applicable Law

This agreement shall be governed by the laws of the State of Nevada.
